- (6) The report must contain a statement that you understand your duty to the court and that you have complied with that duty.
- (7) The report must be verified by a Statement of Truth as follows:
 - 'I confirm that insofar as the facts stated in my report are within my own knowledge I have made clear which they are and I believe them to be true, and that the opinions I have expressed represent my true and complete professional opinion.'
- (8) Pension Splitting for Divorce Ltd has no conflict of interest in this joint instruction
- (9) The pension valuation is within their range of expertise
- (10) The pension report is provided within 28 days of the date of our letter.
